I. Vector Training

The following modules are assigned each year via an email from Vector Training. They are due by **Friday, August 28, 2025**. 1. Bloodborne Pathogen Exposure Prevention Course

Bloodborne pathogens are infectious microorganisms in human blood that can cause disease. This course is designed to provide an overview of the dangers posed by bloodborne pathogens and steps you can take to protect yourself and others from exposure.

2. Child Abuse Mandatory Reporting

This course provides an overview of mandatory reporting requirements regarding child abuse and neglect and states the legal responsibilities.

3. Cybersecurity Overview

This module discusses cybercrimes and the insidious methods cybercriminals use to obtain money and information.

4. Understanding Boundaries

This course is designed to identify opportunities for prevention through policies and practices that protect both staff and students, and to review the responsibilities of staff members as mandatory reporters of child abuse.
